



WHAT IS SATORI?

Satori can monitor your accounts payable, receivable procurement, payroll, master files, travel and entertainment, credit card expenditure, and more, round the clock, proactively identifying unnoticed errors and assigning them to the person responsible for review. The exceptions are tracked through to resolution prior to the payments being processed before they become consequential or catastrophic. Satori ensures your business runs the way it should, with total independent assurance.

UNDER THE HOOD

Satori provides an automated and independent assurance process that ensures that Policies, Procedures, Cross System Checks and System controls are working effectively, efficiently and are well designed and achieving their function continuously.

Let's take a closer look at these with some examples, to get a better insight and context into the makeup and fabric of Satori.

FOR EXAMPLE



POLICIES

Can you be certain that the company policy stating that corporate cards are not to be used for personal expenses or whilst on leave is being monitored and enforced? What about monitoring of contract policies to ensure that contractors do not exceed their contract term and the contracts are renewed following the appropriate procedures?



PROCEDURES

Are you confident that all Purchase Orders have been raised and approved by the appropriate people? Do you identify when a Purchase Order date is after an invoice or payment date?



CROSS SYSTEM CHECKS

Do you monitor potential conflict of interest by identifying matches between employee details and vendor details? What about purchases made on credit cards that may also be processed through accounts payable?



SYSTEM CONTROLS

Can you be certain that the system controls are enabled to ensure appropriate approvals are provided before discounts are applied? What about Segregation of Duties rules which state that a requester of a purchase cannot also be the approver?





MORE THAN EXCEPTION REPORTING



FAST ACTION

Satori provides full exception management – not just reporting. The rules are run on a high frequency, typically daily or weekly, so that when an issue is identified, it is addressed in next-to-real-time, and corrective action taken before the issue has a materially negative impact on the organisation. When detecting inappropriate and fraudulent activity or erroneous transactions – timing is everything to minimise the magnitude of the issue.



TRUE EXCEPTIONS

We focus on delivering High Probability & High Payoff exceptions. The logic of our analytic rules is continuously refined for each customer to minimise the occurrence of false positives within the resulting exceptions. This is in stark contrast to periodic reviews.



REMEDIATION

Satori provides management with greater visibility of the corrective action that has been taken to fix an issue. All activity is captured in a log bringing greater oversight of who corrected what, how, and when.



CONTINUOUS IMPROVEMENT

With Satori, management has a clear understanding of the root cause of issues, allowing well substantiated business improvement decisions.



FULLY AUTOMATE

Satori automates the analytic process that is traditionally manual and ad-hoc. The end-to-end automation is pervasive from data acquisition through to the executive reporting, which frees management to focus on strategic decision-making to improve the internal processes, providing the Executive with the confidence that controls are in place, that they are working, and when an issue arises it is addressed and corrected appropriately.



WORKFLOW MANAGEMENT & VISIBILITY

SATORI ALLOWS YOU TO IDENTIFY:

- What happened to the exception?

 Has it been investigated and closed or is it still open and remains an issue?
- Who is responsible to resolve it?

 A particular member of the team or a group of people?
- Were follow-ups actioned?
 Was it corrected in the customer ERP system, e.g. duplicate invoice cancelled or voided?
- How long did it take?
 Which exceptions are still to be resolved and follow-ups to be commenced?
 Was the review conducted quickly enough to cancel duplicate invoices prior to payment? Has the issue been investigated and closed, or does it remain open?
- What was the root cause?
 The root cause highlights to management the source of their issues and provides a clear opportunity to determine the corrective action required to fix the problem and improve the procedures and processes once and for all.
- Is this a trend or just a random fluctuation?
 The executive reports provide Management with insights into trends and patterns within the data, they highlight outliers, as well as the cause of an issue such as EOFY processing, hire of new staff and lack of training?
- Are our exceptions reducing / controls improving?

 The improvement in error rates illustrated over time, provide Management with an indicator that assurance and governance processes are continuously improving.
